#### **POSITION SUMMARY**

The Outpatient Counselor is a member of the Chemical Dependency Department at the Missoula Urban Indian Health Center (MUIHC) and works within an interdisciplinary team, consisting of a Mental Health Provider, Community Health Promotion Coordinator and Clinical Nurse. The Outpatient Counselor is guided by and under the direct supervision of the Chemical Dependency Department Lead LAC. This is a full-time position, not to exceed 40 hours per week. The position is a grant funded, Indian Preference employment position.

#### **FOCUS AREAS**

The Outpatient Counselor is primarily responsible for provision of chemical dependency treatment services within the continuum of care for individuals seeking chemical dependency treatment in an Outpatient Clinical setting. The Outpatient Counselor is also responsible for meeting Indian Health Service and State of Montana Chemical Dependency Bureau grant program requirements.

#### PREFERRED SKILLS

- Ability to communicate effectively with diverse client base, local area chemical dependency professionals, referring agencies and community partners.
- Knowledge of chemical dependency treatment practices and procedures.
- Sufficient writing skills necessary to maintain complete documentation of client files.
- Strong organizational skills.
- Ability to act as a resource.
- Competence using computers and the internet.
- Attention to detail with proficient planning and organizational skills, sufficient to prioritize and successfully complete job demands.
- Ability to work independently and/or with minimal supervision, as well as, ability to clearly follow supervisor and/or superior's instructions.

#### PREREQUISITE QUALIFICATIONS

- An Associates in Addiction Studies or Bachelor's degree in alcohol and drug studies, psychology, social work, counseling or Human Services related field.
- Must possess a valid State of Montana Licensed Addiction Counselor License.
- One year experience as a Chemical Dependency Counselor in an approved chemical dependency
  program preferred, including experience doing screening, assessment, intervention and rehabilitation of
  chemically dependent clients with co-occurring addiction, mental health and medical problems.
- Knowledge of the twelve (12) care function areas including: screening, intake, orientation, assessment, treatment planning, client placement, individual and group counseling, case management, crisis intervention, client education, referral, record keeping and consultation with other professionals.
- Valid MT Driver's License and clean driving record.
- Be willing to consent to criminal background check.

#### **PHYSICAL DEMANDS**

Essential job duties may require occasional lifting, pushing and pulling up to 50 pounds. The ability to occasionally stoop, kneel, crouch and utilize reaching, handling, fingering and feeling movements is required. The ability to hear normal conversational discussion and near and far visual clarity is required.

Preference in employment is given to qualified Native American candidates, in accordance with Title 42CFR36.221.
